ORDER

Ranvir Singh alias Cheema has filed anticipatory bail application

2. The counsel for the applicant pointed out that the applicant has
been regularly appearing in the trial court, but on 18.5.2019, he could not
appear in the court as he mistook the date. His absence is neither willful nor
intentional. He is ready to face trial and will abide by the terms of bail order.
Therefore, his anticipatory bail application may be allowed.

4. I have gone through the record. Challan in this case has been presented on 11.4.2019. After framing of charge, the case was fixed for prosecution evidence when the accused absented on 18.5.2019 and thereafter PO proceedings were initiated against him. The applicant has absented from the court for the first time. Therefore, taking a lenient view, the anticipatory bail application filed by the applicant is allowed. He is directed to surrender before the Trial Court/Duty Magistrate within ten days from today and then he be released on bail on furnishing personal bonds in the sum of ₹50,000/- with one surety of the like amount to its satisfaction. Trial court record be returned with a copy of this order. Bail application file be consigned to the record room.
