Today is fixed for appearance, production and call for CD.

Accused Mahatabuddin, Haiyat Ali, Jane Alam on court bail are present by filing haziras.

Accused Sk. Jakaria on bail in this case is produced from J.C being shown arrest in connection with another TR case No.02/2024.

Accused Abdur Rasid, Md. Faijul Rahaman and Abdus Salam @ Saha Alam are produced from J/C and remanded to J/C.

Ld. Advocate on behalf of the accused Abdus Salam @ Saha Alam is present and files fresh vakalatnama.

Ld. Spl PP is present.

Ld. Advocates for the accused persons are also present.

One bail petition is filed on behalf of accused persons Abdur Rasid. Copy is served.

Bail petition is moved.

Heard both sides.

Ld. Spl P.P. vehemently opposes the bail prayer and submits the CD is before the Hon'ble Court for bail hearing.

After hearing both sides and on perusal of the case record and materials in CD it appears that initially CS was submitted on 21.07.2022 u/s.419/420/468/471/120B IPC with adding Sec.413/467 IPC r/w Sec. 66D of I.T Act and recently supplementary CS has been submitted on 07.09.2024 u/s. u/s. 409/419/420/468/471/413/467/218/120B IPC r/w Sec. 66D of I.T Act while in both the CS and supplementary CS admittedly name of the accused Abdur Rasid has not been transpired implicating the materials to be attracted u/s.409 IPC. On minutely perusal of the materials in the case record together with the material and CD and specifically statements of accounts of accused Abdur Rashid in respect of his accounts and after comparing with other materials in connection therewith as found in the CD this court finds that it may not be disregarded that there is no material in view of Sec.409 IPC in the instant case as the accused persons have been brought on record after submission of supplementary CS while on perusal of the material submitted in Court at the time of hearing in xerox and comparing the same with the memo of objection submitted by the I.O this Court finds that there are some developments in the case against the accused persons.

In the circumstances, I am not inclined to allow the bail prayer of the accused at this stage.

In the circumstances, in view of the aforesaid, bail prayer of the accused person Abdur Rashid is considered and rejected at this stage.

I.O is directed to submit a complete progress report in the case by the date fixed positively.
