State Vs Sandeep Gupta @ Bulbul Gupta

1. The applicant/accused, **Sandeep Gupta @ Bulbul Gupta S/O Bablu Gupta**, in Case Crime No. 64/2026, U/S 331(4), 303(2) B.N.S., Police Station- Bhaluani, District Deoria, has been arrested and is in judicial custody in jail.

2. Learned counsel for the applicant/accused (A.L.A.D.C.) has submitted that the applicant has not committed any offence and is innocent. The incident is alleged to have occurred on 01.05.2026 at about 9:00 PM, whereas the First Information Report was lodged on 02.05.2026 at 5:45 PM. The applicant/accused is not named in the First Information Report. No recovery of any incriminating article has been made from the possession of the applicant. The offences alleged against the applicant are punishable with imprisonment for a term of less than seven years. The applicant has been in judicial custody in District Jail, Deoria since 19.06.2026. Hence, it has been prayed that the bail application of the applicant/accused be allowed.

3. Learned Assistant Prosecution Officer has opposed the bail application and submitted that the offence committed by the accused is serious in nature. It is prayed that a report from the concerned police station regarding the criminal history of the accused be requisitioned. Therefore, the bail application is liable to be rejected.

4. The submissions advanced by both sides on the present bail application have been heard and the relevant records/documents have been carefully perused.

5. From a perusal of the prosecution papers, it transpires that the allegation against the applicant/accused is that he unlawfully entered the house of the complainant during the night and committed theft of two rings, two pairs of gold earrings, an earthen piggy bank containing ₹8,000, and ₹2,000 kept in a bag for medical expenses. The offence alleged against the applicant/accused is punishable with imprisonment which may extend to fourteen years. Considering the entirety of the facts and circumstances of the case, no sufficient ground for granting bail to the applicant/accused is made out. Accordingly, the bail application moved on behalf of the applicant/accused is liable to be rejected.

O R D E R

The bail application filed on behalf of the applicant/accused, **Sandeep Gupta @ Bulbul Gupta S/O Bablu Gupta**, in Case Crime No. 64/2026, U/S 331(4), and 303(2) of the Bharatiya Nyaya Sanhita (BNS), Police Station Bhaluani, District Deoria, is hereby rejected. A copy of this order be placed on record along with the remand papers.
