Today is fixed for production, appearance and evidence of defacto complainant and victim girl.

Accused Md. Taimur @ Taimur Ali @ Bahadur Ali is produced from J.C through V.C. other accused persons namely Rased Ali, Ruma Khatun, Akhtar Ali and Nihar Khatun are present by filing hazira along with fresh Vakalatnama.

Prosecution files hazira of defacto complainant and victim girl.

Victim girl and defacto complainant are examined in chief, cross-examined in full and discharged as P.W.1 and P.W 2 respectively. Statement of victim girl under section 164 of Cr.P.C and signature of victim girl on it are marked as exhibit P1/PW-1 and Exhibit P1/1/PW-1 respectively. Signatures of victim girl in the consent form and medical examination are marked as Exhibits P2 and P2/1/PW-1 respectively. Signatures of defacto complainant in the written complaint, seizure list dated 22.07.2023 and Zimmanama are marked as Exhibit P2, P4 and P5/PW-2 respectively and birth certificate of victim girl is marked as Exhibit P3/PW-2.

Subsequently, bail petition is filed on behalf of accused person namely Md. Taimur @ Taimur Ali @ Bahadur Ali. Copy of bail petition is served upon Ld. Spl PP.

Heard both sides.

Ld Special P.P has raised objection.

Ld Lawyer for the above named accused person submitted that that he is languishing in jail custody since date of arrest and he has been falsely implicated in this case. He has no involvement with the alleged crime. It is prayed to enlarge the accused on bail.

Perused the entire materials on case record from which it reveals that defacto complainant and victim have been examined in this case on behalf of the prosecution.

Considering the all aspects of this case and on perusal of the evidence of PW-1 (victim girl) and PW-2 (defacto complainant) on behalf of the prosecution and on careful consideration of the submission of both sides I am inclined to allow the prayer for bail of the accused person as I find no good reason to keep the accused person behind the bar.

Hence, the prayer for bail of the accused person Md. Taimur @ Taimur Ali @ Bahadur Ali stands allowed. He may be released on **interim bail** of Rs. 4000/- with two registered sureties of Rs. 2000/- each on condition to attend the court on each and every date fixed for trial.

If on bail, to **02.12.2025** for appearance and evidence of CSW-3 & CSW-4.

03.12.2025 for appearance and evidence of CSW-5 & CSW-6.

The prosecution to take step accordingly.
