Case No. 505/15(S1) has been moved today by his learned counsel Sri P.K. Nanda, for enlarging him on bail. Accused petitioner is taken into custody. Copy of same has already been served to the learned A.P.P. for the State. Learned counsel for petitioner submits that petitioner is surrendering before the Court and praying for bail. It is further submitted that the petitioner is wanted in this case as such he is surrendering today. It is further submitted petitioner is a poor person of the village and is a law abiding citizen. It is further submitted that the petitioner is not willingly or intentionally absent in the Court it is beyond his control. It is further submitted that accused/petitioner has been falsely implicated in this case. It is further submitted that the petitioner is only the earning member of his family and he undertakes to appear before the Court as and when required and abide by all terms and conditions. He is ready and willing to furnish the sufficient sureties for his release on bail and there is no chance of his absconding from justice or tamper with the evidence. Learned A.P.P. opposed the prayer of bail. Heard both sides and perused the case record and submitted that

accused petitioner has been remaining absent in this case since 02.01.2019 and due to his non-appearance further proceeding in this case could not be proceeded.

Perused the case record. It is a case under sections 467,468,406,409,420,120(B),34 of IPC and the accused was granted bail on 30.10.2015. Police after due investigation submitted charge-sheet and after taking cognizance case of this accused was fixed for appearance but the accused from several dates was not appearing in the Court as such, for securing his presence NBW/A was issued by this Court.

As submission advanced by the learned counsel for the petitioner that the petitioner was not aware of the fact and the case was fixed for his appearance and it is first appearance after submission of charge-sheet, I feel inclined to enlarge the accused petitioner namely **Chandra Mohan Purty**, on bail on furnishing bail-bond of Rs. 5,000/- with two sureties of the like amount each with the further condition that the accused/petitioner must remain physically present on each and every date as fixed by the Court and shall furnish his mobile and will change it till disposal of the case. Accordingly, Misc. Cr. Appli. No. 1160/2022 is hereby disposed
