The present application for **anticipatory bail under Section 482 of the B.N.S.S.** has been filed on behalf of the petitioner/accused **Aparna Kundu** in connection with **Kaliyaganj P.S. Case No. 368/2025 dated 12.09.2025**, corresponding to **G.R. Case No. 2371/2025**, under Sections **115(2)/108/103(1)/316(2)/318(2)/351(2) of the B.N.S** and is taken up for hearing today.

The LCR as well as the CD is produced before the Court.

A petition has been filed on behalf of the Ld. Advocate for the accused/petitioner praying for calling for the record in respect of **Kaliyaganj P.S. Case No. 369/2025 dated 12.09.2025**, under Sections **108/115(2)/308(2)/85/3(5) of the B.N.S.** It is submitted that unless the said record is called for, the petitioner/accused may suffer irreparable loss.

Heard the learned Advocate for the petitioner.

Considering the submission made above, **let the record in respect of Kaliyaganj P.S. Case No. 369/2025 dated 12.09.2025 under Sections 108/115(2)/308(2)/85/3(5) of the B.N.S. be called for from the concerned Court.**

Fix 06.03.2026 for hearing.

Let the LCR be retained.

The CD is returned with a direction to produce the same on the date fixed.

This application for bail u/s 483 of B.N.S.S filed on behalf of present accused/petitioner **Badal Paswan** in connection with Hemtabad P.S. Case No.406/2025 dated 07.12.2025 vide GR 3158/2025 u/s 329(4)/109(1)/351(2)/3(5) B.N.S r/w sec. 25/27 of Arms Act is taken up for hearing.

Learned Advocate for the accused/petitioner by filing an affidavit submits that no such application u/s 483 of B.N.S.S is pending in this Court or before the Hon'ble Higher Courts prior to this application.

On query, Ld. Public Prosecutor submits that there is no reflection in the CD that there is any bail application either pending or rejected by Hon'ble Higher Courts and IO also did not intimate him that any bail application is pending or rejected by Hon'ble Higher Courts.

Ld Advocate for the accused/petitioner submits that this accused was arrested on 07.12.2025 and since then he is in custody. Other co-accused persons are on Court bail. Ld Advocate further submitted that this accused is in custody for the last 82 days. Presently, the wife of the accused is at an advanced stage of pregnancy. Ld Advocate further submitted that recovery of firearms is shown in the case. But no such recovery is shown from the possession of this accused. Ld Advocate further submitted that the accused was taken into police custody on two occasions but no fruitful result of such PC was achieved. Further detention of the accused in custody is not required in the interest of investigation. Ld Advocate, accordingly, prayed for bail on any condition.

Ld Public Prosecutor submitted that there is allegation in the FIR on attempting to murder the victim. There is also allegation of using firearms at the time of commission of the offence and the firearms during the course of investigation were also recovered from the custody of other accused Rajib Sarkar. Ld PP further submitted that considering the nature of allegations and considering the stage of investigation, prayer for bail of the accused should be rejected.

Ld Advocate for the de facto complainant submitted that on the last two occasions, prayer for bail in respect of the accused was rejected. This accused is the mastermind of the entire incident. Ld Advocate accordingly prayed for rejection of bail in respect of the accused.

I have perused the case record including the FIR, seizure lists and other relevant documents. It appears that seizure lists show that the firearms have been recovered from the custody of other co-accused who is already on bail.

I have perused the statement of witnesses recorded u/s 180 B.N.S.S. I have also perused the statement of witnesses recorded u/s 183 B.N.S.S. It appears that there are certain ingredients in the CD against the accused.

I have considered the fact that this accused is in custody for the last 82 days. No fruitful result was obtained during PC period. Further detention of the accused in custody does not seem to be necessary in the interest of investigation. Accordingly, prayer for bail u/s 483 B.N.S.S is hereby considered and allowed.

Accused/petitioner namely **Badal Paswan** may find bail of Rs.10,000/- with one surety of like amount, subject to the satisfaction of Ld C.J.M, Uttar Dinajpur at Raiganj and with condition that the accused shall meet the IO every alternative days till further orders. He shall not try to interfere in the process of further investigation and shall not in any manner try to influence witnesses. The accused shall not leave the jurisdiction of this Court without seeking prior approval till further orders.

Thus, the Criminal Misc Case is disposed of accordingly. Return LCR & CD.

This application for bail u/s 483 of B.N.S.S filed on behalf of present accused/petitioner **Rohit Agarwala @ Joy Agarwala** in connection with Raiganj P.S. Case No.1171/2025 dated 13.10.2025 vide GR 2637/2025 u/s 126(2)/115(2)/303(2)/109/3(5) B.N.S is taken up for hearing.

Learned Advocate for the accused/petitioner by filing an affidavit submits that no such application u/s 483 of B.N.S.S is pending in this Court or before the Hon'ble Higher Courts prior to this application.

On query, Ld. Public Prosecutor submits that there is no reflection in the CD that there is any bail application either pending or rejected by Hon'ble Higher Courts and IO also did not intimate him that any bail application is pending or rejected by Hon'ble Higher Courts.

Ld Advocate for the accused/petitioner submits that this accused was taken into custody on 09.02.2026 and since then he is in custody. Ld Advocate further submitted that during this period while the accused remained in custody, police did not pray for any PC in respect of the accused. The detention of the accused in the interest of investigation is not required. There is allegation u/s 109 B.N.S.. However, on considering the FIR, it would appear that there is no such material to attract the provision of sec.109 B.N.S. Ld Advocate, accordingly, prayed for bail on any condition.

Ld Public Prosecutor submitted that there is injury report on record. Considering such injury report and the statement of the victim, prayer for bail should be rejected.

Ld Advocate for the de facto complainant submitted that grievous injury and permanent disablement has been inflicted upon the victim. Earlier, the prayer for anticipatory bail in respect of the accused was rejected. Thereafter, this accused surrendered before the Court. Still now, the accused and his associates are threatening the victims. Ld Advocate accordingly prayed for rejection of bail application.

I have perused the FIR and other relevant documents available in the case record. I have also perused the CD including statement of witnesses recorded u/s 180 B.N.S.S. It appears that there is allegation of assault against the accused.

I have perused the injury report of the victim. It appears that the nature of injury sustained by the victim is grievous in nature.

I have also perused the statement of the victim recorded u/s 183 B.N.S.S.

On perusal of all necessary documents, I am of the view that if the accused is granted bail at this stage, there is every possibility that the accused may try to influence witnesses and also hamper the investigation of this case. Accordingly, at this stage, prayer for bail u/s 483 B.N.S.S of accused/petitioner **Rohit Agarwala @ Joy Agarwala** stands **rejected**.

Thus, the Criminal Misc Case is disposed of accordingly. Return LCR & CD.
