Record is put up today on the prayer of Ld. Advocate made on behalf of accused person namely, **Suvarul Islam @ Fakir**, along with the xerox copy of order dated 20.04.2026 of the Hon'ble Court passed in C.R.M (NDPS) 689 of 2026, under Section 439 of the Code of Criminal Procedure, 1973/ under section 483 of BNSS, 2023.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused **Suvarul Islam @ Fakir**, also files a petition praying for furnishing bail bond in terms of the order of the Hon'ble Court, Calcutta passed in C.R.M (NDPS) 689 of 2026, under Section 439 of the Code of Criminal Procedure, 1973/ under section 483 of BNSS, 2023 dated 20.04.2026.

The Ld. Advocate for the accused also authenticate the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date.

I have perused the order of the Hon'ble Court passed in C.R.M (NDPS) 689 of 2026, under Section 439 of the Code of Criminal Procedure, 1973/ under section 483 of BNSS, 2023 dated 20.04.2026. On perusal of the order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased to pass the following order:-

“..... Therefore, the accused/petitioner, namely **Suvarul Islam @ Fakir** be released on bail upon furnishing bond of Rs. 20,000/-(Rupees Twenty Thousand only), with two sureties of Rs.10,000/- (Rupees Ten Thousand only) each, one of whom must be local, to the satisfaction of Learned Judge, Special Court under NDPS Act, Raiganj, Uttar Dinajpur.

If on bail, the petitioner shall also make himself physically available on each and every date so fixed by the learned Special Court/trial court and shall not leave the district of Uttar Dinajpur without prior intimation to the learned Special Court/trial Court.”

In view of the aforesaid order of the Hon'ble Court, the accused / petitioner **Suvarul Islam @ Fakir** is permitted to furnish bail bond of Rs. 20,000/-(Rupees Twenty Thousand only), with two sureties of Rs.10,000/- (Rupees Ten Thousand only) each, one of whom must be local to the **satisfaction of Ld. C.J.M, Uttar Dinajpur at Raiganj** as to his fitness regarding his release subject to conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action.
