This application for bail u/s 483 of B.N.S.S filed on behalf of present accused/petitioner **Gobinda Dey @ Drubha Ranjan Dey** in connection with Raiganj P.S. Case No.490/2010 dated 07.11.2010 vide GR 1073/2010 u/s 399/402 IPC r/w sec. 25(i)/27/35 Arms Act is taken up for hearing.

Learned Advocate for the accused/petitioner by filing an affidavit submits that no such application u/s 483 of B.N.S.S is pending in this Court or before the Hon'ble Higher Courts prior to this application.

On query, Ld. Public Prosecutor submits that there is no reflection in the CD that there is any bail application either pending or rejected by Hon'ble Higher Courts and IO also did not intimate him that any bail application is pending or rejected by Hon'ble Higher Courts.

Ld Advocate for the accused/petitioner submits that this is a case u/s 399/402 IPC r/w sec. 25(i)/27/35 Arms Act. This accused was earlier on bail. However, at a latter stage, the accused failed to appear and warrant was issued against him. Thereafter, he was arrested on 25.02.2026. Since that time, he is in J/C. Ld Advocate further submitted that this accused shall henceforth appear on every date if he is granted bail. Ld Advocate, accordingly, prayed for bail on any condition.

Ld Public Prosecutor raised formal objection and left the matter to the discretion of the Court.

I have perused the case record including FIR, charge sheet and other relevant documents. I have considered the present facts and circumstances.

It appears from the record that W/A had to be issued against the accused as he had failed to appear. Later, WPA was also issued.

At this stage, I am of the view that one further opportunity may be given to the accused. Accordingly, prayer for bail u/s 483 B.N.S.S is hereby considered and allowed.

Accused/petitioner namely **Gobinda Dey @ Drubha Ranjan Dey** may find bail of Rs.10,000/- with one surety of like amount, subject to the satisfaction of Ld C.J.M, Uttar Dinajpur at Raiganj and with condition that the accused shall appear on each and every date without fail.

Thus, the Criminal Misc Case is disposed of accordingly. Return LCR & CD.
