Today is fixed for hearing of instant Crl. Misc case U/S 482 BNSS. filed on behalf of petitioner namely Aktar Samim.

Ld. Spl. P.P. is present with C.D.

Informant is present by filing hazira.

Ld. Advocate for the petitioner moves the application for anticipatory bail on behalf of petitioner and submits that the petitioner is innocent teacher who has been falsely implicated in this case as the father of the victim is the member of ruling party member. Moreover, there is delay in lodging of FIR and there is no specific allegation against the petitioner of sexual offence. The petitioner is local inhabitants. Ld. Advocate urged for anticipatory bail of the accused / petitioner on any terms and conditions.

Ld. Spl. P.P. raises objection for bail prayer of victim by submitting that the petitioner is geography teacher with bad intention looked towards the victims.

Informant raises objection.

Id. Advocate for the parents of victims raised objection for bail prayer of petitioner and submitted that petitioner is the teacher of victims who has to keep the victim safe but in place of protecting the victims, he look towards them with indecent gesture and bad intention.

Heard the submission of all sides including the defacto complainant.

Perused the instant application U/S 482 BNSS., Statement of VG u/s 183 BNSS, case record and the C.D.

Considering the statement of victims u/s 183 BNSS, statement of witnesses u/s 180 BNSS, facts and circumstances and materials in the C.D, this court finds that custodial interrogation of petitioner is not required for the present case. Thus, I am inclined to allow the prayer of accused petitioner namely Aktar Samim u/s 482 BNSS. Hence, prayer for anticipatory bail is allowed.

In the event of arrest of the petitioner namely Aktar Samim in connection with the above noted case, shall be released on bail of Rs.5,000/- with two sureties of Rs. 2,500/- each subject to the satisfaction of the arresting authority on condition to comply with the provisions as laid down under Section 482(2) BNSS with further condition that he will not threaten or influence the defacto complainant, VG, other witnesses of this case and he will co-operate with the investigation, meet the IO once in a week until submission of CS or until further order.

Return the C.D.

This Criminal Misc. Case is thus disposed of accordingly.
