Today is fixed for production, appearance and report.

Accused Sk. Zakaria and Abdur Rashid were brought under arrest by Karandighi PS along with memo of arrest, accused Chalan, forwarding report seizure list.

Seen the forwarding of PC return, medical slips, accused chalan.

The accused persons are taken into custody.

Ld. Lawyer for accused files a petition for bail along with Vokatnama. Copy served.

Heard both sides. Perused the case record.

On perusal of the case record, I find that investigation is at early stage and the case involves the lots of government money and they are habituated to making fake online registration on fictitious students for scholarship grants. Considering the nature and gravity of the alleged offence, the prayer for bail of accused persons are considered and rejected.

Accused Saha Alam @ Abdus Salam is produced from J/C and remanded to J/C.

Accused Faijal @ Md. Faijal Rahaman is not produced from J/C due to unavailability of police escort.

Accused persons Mahatabuddin, Sakir Ali, Md. Tahasen, Zane Alam, Hayat Ali, Sarjahan Ali, Panchu Basak and Ashok Gupta on bail are present by filing haziras along with their Ld. Advocates.

IO is present with CD.

Ld. Counsels of both sides are present.

Bail petition is filed on behalf of the accused persons Faijal @ Md. Faijal Rahaman and Saha Alam @ Abdus Salam. Copy served.

Bail petition is kept with the case record.

Perused the case record and CD.

The IO is present with a prayer for 07(seven) days PC of the accused persons and recommended by Deputy Supdnt of Police, CID, Malda, West Bengal.

He has prayed for permitting him to take the accused persons in police custody for **07 days** for the purpose of the effective investigation and to nab the other racketeers involved in the case.

I have examined the CD. It appears to me that granting the prayer for police custody to trace out and bursting out the involved miscreants and to recover more money and money mule accounts is necessary and also for the interest of investigation.

In view of above, the prayer for police custody of accused persons is hereby allowed for **05 days**.

IO is permitted to take the accused persons **Zakaria and Abdur Rashid in police custody for 05 days i.e. for 17.08.2024 to 21.08.2024**. IO is directed to strictly follow the guidelines as given by the Hon'ble Apex Court while the accused persons will be in police custody. He is further directed to get the accused persons examined medically on every interval of 24 hrs and to produce them before this Court on **21.08.2024 at 01:00 p.m.**

In the circumstances IO is directed to be present in person with CD by the date fixed positively.

To **21.08.2024** for production of accused persons from PC, appearance of IO.

Let a copy of the order be supplied to the IO in open Court for strict compliance.
