ORDER

Today, accused is present before this Court due to National Lok-Adalat. Upon inquiry, I am satisfied that accused is pleading guilty voluntarily. Hence, I accept the plea of guilty of the accused and hold him guilty for the respective offence alleged against him. Heard the accused on the point of sentence. It is submitted that, he is the only earning member of his family. The accused had no sufficient source of income. Considering the nature of offence and financial position of accused in my view there are sufficient grounds for imposing lesser punishment on the accused. Hence, I proceed to pass the following order :

ORDER

1) The accused namely **Pranay Ganesh Burde** is hereby convicted for contravening the provision of section punishable under section 285 of BNS vide Section 275 of BNSS, 2023 and he is sentenced to pay fine of Rs.**300/-**(Three Hundred Rupees Only) and in case of default to pay the amount of fine he shall under go simple imprisonment for 3 days.
