Record is put up today on the prayer of Ld. Advocate made on behalf of accused Amir Mahammad @ Amir Md. @ Choko along with the downloaded server copy of order dated 20.11.2024 of the Hon'ble Court passed in C.R.M (NDPS) 1642 of 2024, U/S 439 of Cr.P.C.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused Amir Mahammad @ Amir Md. @ Choko also files a petition praying for furnishing bail bond in terms of the order of the Hon'ble Court, Calcutta passed in C.R.M (NDPS) 1642/2024 dated 20.11.2024.

The Ld. Advocate for the accused also authenticate the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date

I have perused the order of the Hon'ble Court passed in C.R.M (NDPS) 1642/2024 dated 20.11.2024. On perusal of the order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased to pass the following order:-

"...4. Therefore, the accused/petitioner namely, Amir Mahammad @ Amir Md. @ Chok be released on bail upon furnishing bond of Rs.10,000/- (Rupees Ten thousand only), with two sureties of like amount each, one of whom must be local, to the satisfaction of the Learned Additional District & Sessions Judge, 1st Court-cum-learned Judge, Special Court (NDPS Act), Raiganj, Uttar Dinajpur subject to condition that the said petitioner shall appear before the Trial Court on every date of substantive hearing subject to the provisions of Section 317 of the Code of Criminal Procedure 1973/ Section 355 of Bharatiya Nagarik Suraksha Sanhita, 2023 and shall not intimidate witnesses and/or tamper with evidence in any manner whatsoever and on further condition that the petitioner, while on interim bail, shall not leave the territorial jurisdiction of Goalpokher Police Station, except for the purpose of attending Court proceedings, until further orders. .

5. In the event petitioner fails to adhere to any of the conditions stipulated above without any justifiable cause, his interim bail shall stand automatically cancelled without further reference to this Court".

In view of the aforesaid order of the Hon'ble Court, the accused Amir Mahammad @ Amir Md. @ Chok is permitted to furnish bail bond of Rs.10,000/- with two sureties of like amount each, one of whom must be local to the **satisfaction of this court** regarding his release subject to conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action
