ORDER.

1. Gurwinder Singh (here-in-after to be referred as bail applicant) has moved an application under Section 439 Cr. P.C., for grant of regular bail in case FIR No.196 dated 31.10.2022, under Section 21 of the NDPS Act, Police Station Bhikhi.

2. Upon notice, Ld. Addl. Public Prosecutor has appeared to represent the State and to contest the bail application.

3. I have heard learned counsel for the applicant and learned Addl. PP for the State and have gone through the record carefully.

4. Learned counsel for the bail applicant contended that latter is innocent and has been falsely implicated in this case. Nothing has been recovered from him. He has been in custody since 31.10.2022 and is not required for any investigation purpose. Presentation and disposal of challan will take time. Therefore, the prayer to admit applicant to regular bail.

5. Ld. Addl.P.P. for the State opposed the prayer seeking dismissal of application in view of the nature of offence.

6. As per version of Investigating Agency, this applicant alongwith his co-accused was apprehended on 31.10.2022 while allegedly possessing 10 grams Heroin. Recovery of that contraband has already been effected. Being in judicial custody, applicant is not required for any investigation purpose. Presentation and disposal of challan will take time. Culpability of applicant will be decided in regular trial. Therefore, without commenting on merits of the case, accused/applicant is admitted to regular bail on furnishing his personal bonds in the sum of Rs.50000/- with one surety in the like amount. Bail application file be attached with remand papers which be returned to Ahlmad.
