State vs. Simran Singh @ Sonu Baba

ORDER

This order of mine shall dispose of above said bail application under Section 439 of The Code of Criminal Procedure being filed by accused/applicant Simran Singh @ Sonu Baba son of Sh.Charan Singh resident of Gurudwara Di Backside, Village Meharban, District Ludhiana, in FIR No.116 dated 26.08.2020, under Sections 379-B, 506, 34 of the Indian Penal Code, Police Station Meharban, Ludhiana. Judicial record produced and perused. Allegations against the accused/applicant are that the instant case was registered on the basis of statement made by complainant Azad Alam son of Rehman to the effect that on 24.08.2020 at about 07:30 PM, he was coming to his house after executing his work in the factory and when he reached Priya Colony in front of GDS Public School, Meharban, Ludhiana, two Muslim persons were seen coming on foot. They encircled him. One of the said persons pointed a Datar like object on his neck after taking out the same from the back Dab of his pants and the second person took out his mobile make Samsung from front right pocket of his pants. He also took out his purse of black colour containing Rs.500/- and Adhar Card from the backside right pocket of his pants. The persons who pointed Datar like object on him also snatched his silver chain after threatening him. Thereafter, they fled away from the spot alongwith weapon after threatening him, towards Mohalla Harkishan Vihar, Kande Wali Gali, Meharban, Ludhiana. On inquiry, he came to know their names as Sunny resident of Harkrishan Vihar and Simran Singh @ Sonu resident of Village Meharban, Ludhiana. He could identify them, if brought before him. Perusal of judicial record reveals that challan in this case has already been presented in the court of Ms.Rajbir Kaur, Judicial Magistrate Ist Class, Ludhiana on 10.10.2020. Allegations are matter of trial. Accused/applicant is in custody since 26.08.2020. No useful purpose is served by detaining the accused/applicant further in custody. Accordingly, applicant/accused Simran

Singh @ Sonu Baba is ordered to be released on bail in this case on furnishing on personal bonds in the sum of Rs.50,000/- with one surety in the like amount to the satisfaction of the Ld.Illaqa/Duty Magistrate, Ludhiana. Accordingly, the instant bail application is allowed. Judicial record alongwith copy of this order be returned. This file be consigned to the record room.
