Today is fixed for consideration of charge.

Ld. PP-in-Charge is present and the entire five accused persons on court bail are present by filing their respective haziras.

Perused the materials on record including the written complaint, CS and CD. Considered.

It appears from the available materials record that there exist sufficient materials to frame charges against the accused Gobin Chandra Das @ Gobinda punishable under section **376/493 of the I.P.C.**

The substances of the charges so framed punishable under section **376/493 of the I.P.C** are read over and explained to the accused Gobin Chandra Das @ Gobinda to which he pleaded not guilty of committing offence by saying "Ami Nirdosh" in Bengali language and claimed to be tried.

Accordingly, the charges punishable under section **376/493 of the I.P.C** is framed against the accused Gobin Chandra Das @ Gobinda.

On the basis of available materials the charges punishable under section **307/34 of the I.P.C. is framed** against remaining 4 accused persons.

The substances of the charges so framed punishable under section **307/34 of the I.P.C** are read over and explained to the remaining 4 accused persons to which they pleaded not guilty of committing offence by saying "Amra Nirdosh" in Bengali language and claimed to be tried.

Accordingly, the charges punishable under section **307/34 of the I.P.C** are framed against the remaining 4 accused persons.

Formal charge are accordingly prepared and kept in the record.

Let the session case is registered in Trial Register as **Session Trail being No. 54 of 2023**. DA to make necessary entry in the CIS and relevant registers.

Issue summons accordingly.
