Record is put up today on the prayer of Ld. Advocate made on behalf of accused Achinta @ Achinta Tarafdar @ Babua and Mithun Ghosh, along with the xerox copy of order dated 06.06.2026 of this Ld. Court passed in Crl. Misc. No. 687 2026 and 776 of 2026, U/S 483 of the BNSS.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused/petitioners Achinta @ Achinta Tarafdar @ Babua and Mithun Ghosh also files a petition praying for furnishing bail bond in terms of the order of the Ld. Court, ADJ, 1st Court, Raiganj, U/S 483 of BNSS dated 06.06.2026.

I have perused the order of this Court, U/S 483 of BNSS dated 06.06.2026. On perusal of the order of the Ld. Court, it appears that the Court has been pleased to pass the following order:-

“..... Therefore, the accused/petitioners, namely Achinta @ Achinta Tarafdar @ Babua and Mithun Ghosh be released on bail upon furnishing bond of Rs.5,000/- (Rupees Five Thousand Only) each with one surety each.

If on bail the petitioners shall the comply the following conditions :

- a. *The accused-petitioners shall report before and cooperate with the Investigating Officer twice every week for a period of one month from the date of their release on bail, or until submission of the final report, whichever event occurs earlier;*
- b. *The accused-petitioners shall not leave the territorial jurisdiction of Raiganj Police Station, save and except for attending any judicial proceeding or upon obtaining prior leave of the Learned Trial Court, and this condition shall remain operative until submission of the final report;*
- c. *The accused-petitioners shall neither directly nor indirectly intimidate, influence, induce, or otherwise interfere with any witness connected with the case, nor shall they tamper with the evidence or impede the course of investigation in any manner whatsoever..”*

In view of the aforesaid order of the Ld. Court, the accused persons Achinta @ Achinta Tarafdar @ Babua and Mithun Ghosh are permitted to furnish bail bond of Rs. 5,000/-(Rupees Five Thousand Only) each with one surety each, to the **satisfaction of Ld. C.J.M, Uttar Dinajpur at Raiganj** regarding his release subject to conditions as stipulated by this Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action
