IO is present with CD along with a prayer for 14 days PC of the accused persons Altaf Raja and Toufik Rahaman are brought under arrest today.

Seen the accused challans, memos of arrest, medical slips, forwarding reports.

Accused persons are taken into custody and remanded to JC.

I.O has also produced one white colour plastic sack tied with rope in sealed condition stated to have been containing seized ganja weighing about 21 kgs as per the seizure list including one card reader (microchip/SD card) stated to have been containing videography of search and seizure process along with one big size sealed envelope stated to have been containing two android mobile phones, one PAN card, Aadhar card and Voter identity card of accused Altaf Raja.

Ld. Advocate for the accused persons files bail petition on behalf of the accused persons along with vakalatnama and also with a prayer that the accused Toufik Rahaman is a juvenile and so he prays to pass necessary order.

The Ld. PP-in-charge has prayed for police custody of the accused persons as per the prayer of the I.O.

Ld. Advocate for the accused persons moves the bail prayer and the prayer for juvenility of the accused Toufik Rahaman.

Heard both sides.

Perused the case record and CD.

On perusal of the case record and the CD it appears that the case involves recovery of 21 kgs ganja.

Accordingly, the bail prayer of the accused persons is considered and rejected.

However, after hearing both sides with regard to accused Toufik Rahaman on the ground of his juvenility, I find a report is required to pass necessary order in this regard.

Accordingly, I.O is directed to submit a complete report as to juvenility of the accused Toufik Rahaman by the date fixed positively, id necessary order shall be passed.

The IO is present with a prayer for 14(fourteen) days PC which has been recommended by Additional SP, Islampur PD.

He has prayed for permitting him to take the accused persons in police custody for **14 days** for the purpose of the effective investigation.

I have examined the CD. It appears to me that granting the prayer for police custody to trace out and bursting out the involved miscreants and to recover more contraband articles is necessary and also for the interest of investigation.

In view of above, the prayer for police custody of accused persons is hereby allowed for **07 days**.

IO is permitted to take the accused persons **in police custody for 07 days i.e. for 28.03.2025 to 03.04.2025**. IO is directed to strictly follow the guidelines as given by the Hon'ble Apex Court while the accused person will be in police custody. He is further directed to get the accused persons examined medically on every interval of 24 hrs and to produce them before this Court on **03.04.2025 at 1:00 p.m.**

To date (**03.04.2025**) for production of PC accused.

Let a copy of the order be supplied to the IO in open Court for strict compliance.
