Record is put up today on the prayer of Ld. Advocate made on behalf of accused **Altaf Raja**, along with the xerox copy of order dated **22.01.2026** of the Hon'ble Court passed in C.R.M (NDPS) 1685 of 2025, U/S 439 of the Code of Criminal Procedure, 1973 corresponding to Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023.

The Ld. PP is present. Copy served.

The Ld. Advocate for the accused **Altaf Raja** also files a petition praying for furnishing bail bond in terms of the order of the Hon'ble Court, Calcutta passed in C.R.M (NDPS) 1685 of 2025, U/S 439 of the Code of Criminal Procedure, 1973 corresponding to Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023, dated 22.01.2026.

The Ld. Advocate for the accused also authenticate the factum of the order of the Hon'ble Court supported by affidavit and also undertakes to file original certified copy of order of the Hon'ble Court within a month from this date

I have perused the order of the Hon'ble Court passed in C.R.M (NDPS) 1685 of 2025, U/S 439 of the Code of Criminal Procedure, 1973 corresponding to Section 483 of the Bharatiya Nagarik Suraksha Sanhita, 2023, dated 22.01.2026. On perusal of the order of the Hon'ble Court, it appears that the Hon'ble Court has been pleased to pass the following order:-

“..... Therefore, the accused/petitioner, namely **Altaf Raja** shall be released on bail upon furnishing bond of Rs.20,000/-, with two sureties of Rs.10,000/-each, one of whom must be local, to the satisfaction of Learned Special Court under NDPS Act, Raiganj, Uttar Dinajpur.

If on bail the petitioner shall be physically present on each and every date so fixed by the learned Trial Court and shall not leave the jurisdiction of district of Uttar Dinajpur without the prior permission of the learned Special Court.”

In view of the aforesaid order of the Hon'ble Court, the accused **Altaf Raja** is permitted to furnish bail bond of Rs. 20,000/- with two sureties of Rs. 10,000/-each, one of whom must be local to the **satisfaction of Ld. C.J.M, Uttar Dinajpur at Raiganj** regarding his release subject to conditions as stipulated by the Hon'ble Court.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.

Let a copy of this order be sent to Ld. CJM, Raiganj, Uttar Dinajpur for information and taking necessary action
