**“Accordingly, the accused/petitioner Md. Muslain @ Md. Muslim @ Moslem Ali @ Maslam Ali shall be released on bail upon furnishing a bond of Rs.10,000/- with two sureties of like amount each, one of whom must be local, to the satisfaction of the Ld. Judge, Special Court under the NDPS Act, Raiganj, Uttar Dinajpur subject to condition that he shall appear before the trial court on every date of hearing until further orders and shall not intimidate witnesses or tamper with evidence in any manner whatsoever.**

**In the event the petitioner fails to appear before the Trial Court without any justifiable cause, the trial Court shall be at liberty to cancel his bail in accordance with law without further reference to this Court.**

In view of the order of the Hon'ble Court, the accused **Md. Muslain @ Md. Muslim @ Moslem Ali @ Maslam Ali** is permitted to furnish bail bond of Rs.10,000/- with two sureties of like amount each, one of whom must be local subject to the satisfaction of this court along with condition as imposed by Hon'ble High Court.

Let the downloaded copy of the order of the Hon'ble Court be kept with the record and Ld. Defence Counsel is directed to furnish original certified copy of the order of the Hon'ble Court at the earliest.
