IO is present with CD along with a prayer for **5 days PC** of accused namely, **Rahul Roy @ Rahul** who has been arrested by police of Raiganj PS.

Ld. Advocate appears on behalf of the accused person by filing fresh vakalatnama which is found fit and accepted. The same is kept with the record.

One bail petition is filed on behalf of the accused person **Rahul Roy @ Rahul**.

Ld. P.P in charge is present. Copy of bail petition is served upon the prosecution.

Ld. Advocate submitted that the prayer for police custody of 05 days is not required and the same should be rejected. Ld. Advocate further submitted that the accused person is not involved in the alleged offence and he has been falsely implicated in this case. Ld. Advocate further submitted that only 25 bottles of triprolidine Hydrochloride and Codeine Phosphate Cough Syrup "PHENSEDYL" is shown has seized from the custody of accused. Also, seizure of fire arms has been shown from the possession of the accused.

Ld. Advocate further argued that entire facts as shown are false and fabricated and the accused has been falsely framed. Ld. Advocate prayed for rejection of the prayer for PC and prayed for allowing the bail to the accused.

Ld. PP raised strong objection. It is submitted that 25 bottles of triprolidine Hydrochloride and Codeine Phosphate Cough Syrup "PHENSEDYL", each contains 100 ml (Total 2500 ml.) has been recovered from the conscious possession of the accused person. The investigation is going on. The accused person is FIR named. There is possibility of involvement of other persons in the alleged offence. There is also possibility of recovery of more narcotic substances. Considering the same, the prayer for bail be rejected and PC for 5 days be allowed.

I have considered submission of both sides. Perused the FIR and other available documents including the seizure list. The IO is personally present. Heard the IO in person who stated that PC is required for recovery of further narcotic substances and to arrest other persons involved in the alleged offence and also to unearth more truths/evidence.

Considering the facts and circumstances, and considering the interest of fair investigation and also considering the fact that prima facie there is no material to come to any finding that the accused person is not involved in the alleged incident, I am inclined to allow the prayer for PC, but for **3 days**.

The I.O shall take the accused person in PC and produce him on **16.03.2026**.

Bail petition in respect of accused namely, **Rahul Roy @ Rahul** accordingly, stands rejected.

IO is directed to strictly follow the guidelines as given by the Hon'ble Apex Court while the accused person will be in police custody. He is further directed to get the accused person examined medically on every interval of 24 hrs and to produce him before this Court on **16.03.2026 at 1:00 p.m.**

To date (**16.03.2026**) for production of PC accused person.

Let a copy of the order be supplied to the IO in open Court for strict compliance.
