Today is fixed for production and I.O's report and also production of CD.

Accused Rahul Roy @ Rahul is produced from JC through VC mode and remanded to J.C

Ld. Advocate is present and filed a petition praying for bail for accused **Rahul Roy @ Rahul**.

Ld. P.P in charge is present and filed a petition u/s 37 of NDPS Act praying for rejection of bail petition.

Copy of bail petition is served upon the prosecution.

Bail petition is moved.

Heard both sides and perused the case record.

CD is produced on this date.

Ld. Advocate submitted that accused is in custody since 12.03.2026. He was taken into custody for three days and the purpose of the PC is served. Ld. Advocate emphasis that during PC , no fruitful result could be achieved. The I.O has not prayed for further PC. Ld. Advocate further submitted that the accused person is not involved in the alleged offence and he has been falsely implicated in this case. Ld. Advocate further submitted that only 25 bottles of triprolidine Hydrochloride and Codeine Phosphate Cough Syrup "PHENSEDYL" is shown has seized from the custody of accused. Also, seizure of fire arms has been shown from the possession of the accused.

Ld. Advocate further argued that entire facts as shown are false and fabricated and the accused has been falsely framed. Ld. Advocate prayed for allowing the bail to the accused.

Ld. PP raised strong objection. It is submitted that 25 bottles of triprolidine Hydrochloride and Codeine Phosphate Cough Syrup "PHENSEDYL", each contains 100 ml (Total 2500 ml.) has been recovered from the conscious possession of the accused person. The investigation is going on. The accused person is FIR named. There is possibility of involvement of other persons in the alleged offence. There is also possibility of recovery of more narcotic substances. Moreover on earlier occasion the bail prayer of this accused was rejected. Considering the same, the prayer for bail be rejected.

I have considered submission of both sides. Perused the FIR and other available documents including the seizure list.

Considering the facts and circumstances, and considering the interest of fair investigation and also considering the fact that prima facie there is no material to come to any finding that the accused person is not involved in the alleged incident, I am not inclined to allow the prayer for bail to the accused.

Bail petition in respect of accused namely, **Rahul Roy @ Rahul** accordingly, stands rejected.

Accused is remanded to JC till **16.04.2026**.

To date (**16.04.2026**) for production of accused person and I.O's report.

Return CD.

I.O is directed to produce the CD on the date fixed ie on 16.04.2026.
