The IO has submitted a report regarding ownership of the seized vehicle bearing registration No. WB60H/0623. Let the same be kept with the record.

Ld. Advocate appearing on behalf of the owner files a petition along with firishti consisting of certificate of registration and Insurance policy of the said vehicle for returning back the vehicle to its registered owner.

Heard Ld. Spl.PP and Ld. Advocate appearing on behalf of the petitioner/ the registered owner.

It appears on perusal of the report of I.O. that he prayed for further time to inquire regarding the ownership of the seized vehicle bearing No. WB60H/0623 and during his enquiry, he collected the vehicle owner details of the said vehicle from O.C SOG, Karnojora, Raiganj PD but nobody turned up or produced any document before him in respect of the seized vehicle bearing No.WB60H/0623.

I find that the report gives out clearly that the petitioner/ Lakshmi Sarkar is the registered owner of motorcycle bearing No. WB60H/0623. From the document which is filed by the petitioner that Lakshi Sarkar is the owner of the vehicle and the said vehicle is also covered by Insurance Policy.

In view of above let the motorcycle bearing No. WB60H/0623 be returned to its registered owner Lakshmi Sarkar with its connected documents on his executing PR bond of Rs.1,00000/- on conditions that he shall not change the nature and character of the said vehicle, he shall not, in any way, sell or otherwise transfer and/or dispose of the said vehicle in any manner whatsoever till completion of this case and on condition to produce the same as and when called for by this Court.

The IO is directed to return the said vehicle to the owner namely Lakshmi Sarkar of Pasal Hat, Pokhoria, Goalpokher, Uttar Dinajpur within three days after receiving of this order.

To date also for supply of copy and for filing appointment letter of the Spl.PP.

Let a copy of this order be sent to the concerned IO for information and taking necessary action.
