2. This order shall dispose of first anticipatory bail application under Section 482 BNSS.

3. The ld. Counsel for applicant/accused argued that the applicants have two children i.e. one daughter Yogita Rani who is already married in the year 2010 and now she is happily residing with her husband in her in laws house separately. And the applicant has one son namely Naveen Sannan who is residing in Singapore, where Naveen Sannan came into contact with one Harsimranjit Kaur D/o Manjit Singh R/o Vill.Hussainpur Guru, PO. Kotla Naudh Singh, Tehsil and District Hoshiarpur. In the year 2022 Naveen Sannan and Harsimranjit Kaur came to India and they both got love marriage with each other on 04.01.2022 without giving and taking dowry. Soon after the marriage Naveen Sannan returned to Singapore and after few days, Harsimranjit Kaur also return to her husband in Singapore where they resided together as husband and wife and one child born from their wedlock. However, some dispute arose between both Naveen Sannan and Harsimranjit Kaur in Singapore but Harmismranjit Kaur in collusion with her father started harassing the old aged applicants residing in India. That applicants have no link or connection with married life of said Harsimranjit Kaur and Naveen Sannan. That father of Harsimranjit Kaur forcing the applicants to transfer their whole properties on the name of the said Harsimranjit Kaur, otherwise threatened to involve the applicants and her family members in false cases. That the father of said Harsimranjit Kaur namely Manjit Singh was police employee and recently retired from Police Department, Hoshiarpur and due to that he has good relations with higher

police officials, therefor, he by misusing the said relations got moved false application from either himself or through her daughter Harsimranjit Kaur against the applicants and her family. As such, the applicants and her family is being harassed by the DSP, Hoshiarpur, and under the garb of inquiry and several times the applicants were called, joined in enquiry, recorded their statements, got signatures on several forms but all the time the police misbehaved with the applicants and used to humiliate and threatened them. It is further argued that police is raiding the house of applicants to arrest them whereas they are ready to join investigation. So, he prayed that the accused may kindly be released on anticipatory bail.

4. On the other hand, Ld. Addl. PP for the State opposed the bail application on the ground that no FIR has been registered against the accused/applicants in any offence and inquiry is still pending, so he prayed that the bail application may kindly be dismissed.

5. ASI Raj Kumar appeared and got recorded his statement that he has brought the record pertaining to the present case. The inquiry in complaint filed by the complainant Harsimranjit Kaur against the applicants Kavita Rani and Mahinder Singh is pending and no FIR is registered against them till date.

6. Since as per statement of ASI Raj Kumar, enquiry is pending, but no FIR has been registered against the applicants/accused till date, present bail application has become infructuous and the same is hereby dismissed. File be sent to the court of Id.Sessions Judge, Hoshiarpur, for its

entrustment so that the file may be consigned to the record room by that court to which court it will be entrusted.
