Soma Bodra</b> have been produced from Observation Home Chaibasa.</p> <p>From perusal of the record, it transpires that the above mentioned CICL are facing enquiry in this case for the offence punishable U/s 461/379 of IPC .</p> <p>On further perusal of the record it appears that the above named CICL were produced before this Board on 21.11.2022. The age of the juveniles namely Roshan Bodra and Tushar Bodra and Soma Bodra was assessed by this Board as 12 years, 19 years and 16 years respectively. The said juvenile were under the age of 18 yaers on the date of occurrence. The record further shows that the informant Neha Singh was examined by the prosecution.
