The record is taken up for hearing.

Ld Lawyer appearing on behalf of the accused submits that the accused is a lady and she is in custody since 24.09.2019. Ld Advocate further submits that 01 year and 6 months baby with her in her lap. As such, he prays for bail for on any terms and conditions since she has never filed application u/s 439 Cr.P.C prior to this application.

On the other hand, Ld PP opposes the bail prayer and submits that charge has already been framed against the preset accused and altogether four witnesses have been examined.

Heard both sides. Perused the case diary and LCR.

Having heard the submissions of both sides and on perusal of entire materials available on record and the evidence of witnesses, I am inclined to allow her prayer for bail since there is no possibility of early trial during this pandemic of Covid-19 .

The accused person namely Jaba Hasda may find **Interim bail** of Rs. 10,000/- with two sureties of Rs.5,000/- each, with condition to attend the Court on each and every date fixed by the Court, subject to satisfaction of the Ld CJM, Uttar Dinajpur, id to J/C till 21.09.2020.

To date,ie, 21.09.2020 for appearance, if on Interim bail.

Today is fixed for production of accused Faijul Hoque @ Sk.

Accused Faijul Hoque @ Sk is produced from J/C.

One bail petition is filed on behalf of accused.

Hd. Ld. Advocate for the accused person and the Ld. PP.

Ld. Advocate for the accused submits that due no miscommunication he could not appear and W/A was issued against him on 08.07.2019 and he voluntarily surrenders before the Court on 16.08.2019. So, he prays for bail in any terms and condition.

Ld. P.P. leaves the matter to the discretion of the Court.

Considered their submission and the material in case record.

It appears that the accused was absent on 08.07.2019 and as such he breached the condition of bail and his earlier bail was cancelled and W/A was issued against him but on 16.08.2019 he voluntarily surrendered before the Court and since then he is in custody. Now he undertakes to appear and assist the Court on each and every date.

Considering the above facts and circumstances in the light of his undertakes made by the petitioner, his prayer for bail may be allowed on interim basis.

that the accused person namely Faijul Hoque @ Sk may find **Interim bail** of Rs. 6000/- with two sureties of Rs. 3,000/- each, out of which one must be Advocate surety and another must be registered surety, with condition to attend the Court on each and every date fixed by the Court, subject to satisfaction of the Ld CJM, Uttar Dinajpur, id to J/C till 09.09.2019.

To date,ie, 09.09.2019 for appearance of accused, if on interim bail.
