Today is fixed for production of accused Samsul Haque and IO's report.

Accused Samsul Haque is produced from J/C and remanded to J/C.

Today is also fixed for production of CD.

One bail petition is filed on behalf of the accused person. Copy served.

Ld. Counsels are both sides are present.

CD is produced.

Bail petition is moved.

Ld. Lawyer for accused submits that the accused is in custody since 07.05.2024. It is also submitted that in the meantime the accused is in custody for 16 days and there is no material in the case record against the accused. It is further submitted that the PC remand of the accused did not yield any result and the accused has been shown arrest in the case being arrested and produced in connection with Special E. Case 116 of 2024 arising out of Goalpokher PS. Csse No.87 of 2024 dated 20.02.2024 u/s.136 of the Electricity Act. It is submitted that till date there is no developmemnt in the case record against this accused. He further submits that accused is only earning member of his family. Accordinngly, he prays for bail on any condition.

Ld. Spl. PP opposes bail prayer.

Heard both sides. Perused the case record and CD.

On perusal of the case record, I find that the accused has been shown arrest in this case on 10.05.2024 and since then accused is in custody in this case. On minutely perusal of the statement recorded u/s.161 Cr.P.C and other materials as collected by the IO in CD and after comparing the same with the FIR, this court does not find specifically name of the accused in the FIR with respect to the allegations as made out there and at the same time I do not find sufficient materials to establish a prima facie case at this stage against the accused u/s.136 of the Electricity Act and so for further detention of the accused in J/C.

In view of thr aforesaid facts and circumstances, considering the other materials on the case record and CD, this court finds that the accused may be released on interim bail on some stringent conditions.

Accordingly, the accused persons **Samsul Haque** may find **interim bail** of Rs.4,000/- with two registered sureties of Rs.2,000/- each the the satisfaction of this court and on conditions that the accused shall not leave jurisdiction of the local PS and shall meet the IO once in a week by maintaining a diary till submission of report in final form and shall appear in court on each fixed date, ID to J/C till 30.07.2024.

Fitness of the bail bonds as above be endorsed by the Ld. CJM, Raiganj, Uttar Dinajpur and the same shall be returned to this court for acceptance.
