

ORDER BELOW EXH.1 IN RCC 211/2021

(CNR: MHSN08-000975-2021)

(State Vs. Raju Lengare & Ors.)

1. The officer in charge in CCTNS C.R. No. 177/2021 registered with Jath Police Station, has filed the report (Charge Sheet) under section 173 (2) of Cr.P.C. against the accused persons.
2. Today accused No. 1) Raju Balu Lengare and 2) Adhik Siddhu Hake are produced before me at 5.00 pm through electronic video linkage from Central Jail, Sangli by Constable Shri. P. B. Sutar.
3. The offence leveled against the accused is punishable u/s. 302, 120 (B), r.w. 34 of Indian Penal Code. The offence punishable u/s 302 is exclusively triable by the Hon'ble Court of Sessions. Hence, the case is committed for trial to the Hon'ble Court of Sessions, Sangli.
4. The copies of police report and other documents as specified in section 207/208 of Cr.P.C. have been supplied to the accused by sending the same with letter of this court bearing Ow. No. 3442/2021 dated 08.12.2021. The said letter has been properly served upon the accused by police constable J. D. Shaikh, Bakkal No. 2550 of Jath Police Station through Jail Authority and endorsement of the accused in respect of receipt of charge-sheet and other documents alongwith it has been obtained upon the same. On inquiry with the accused about engaging their lawyer they stated that they have already engaged their lawyer Mr. S. B. Saudagar for accused No. 1 and Mr. A. G. Revoor for accused No. 2 on his behalf

and he also stated that he will also engage another lawyer in addition to the lawyer engaged by him earlier of his choice to represent him in the Hon'ble Sessions Court.

5. The accused are intimated and directed to appear before Hon'ble Court of Sessions, Sangli on **29.12.2021**. The jail authority is directed to take note of this date and to produce the accused before Hon'ble Sessions Court, Sangli.
6. All the record of the case and the documents, articles, which are to be produced in the evidence be sent to the Hon'ble Court of Sessions, Sangli.
7. The Police Station Officer, Police Station Jath be directed to produce muddemal property in the Court of Sessions on or before **29.12.2021**.
8. The Public Prosecutor be notified of the committal of the case to the Hon'ble Court of Sessions, Sangli.
9. The copy of the order be sent to the Superintendent District Central Jail, Sangli for information and further necessary action.
