Today is fixed for appearance, production and evidence of CSW No.3.

Out of three accused persons, two accused persons namely, **Jahid Alam and Parwed Alam** are absent but represented u/s 317 of Cr.PC by their Ld. Lawyer and another accused **Dhola @ Basir** is produced from J/C through VC Mode.

Ld. Advocate for the accused person is present and filed one petition praying for bail to the accused **Dhola @ Basir**.

Ld. P.P is present and filed a petition u/s 37 of NDPS Act praying for rejection of bail.

No witness has turned up today.

It appears that today is the last date of evidence of the previous schedule.

Now a fresh schedule is fixed which follows :

Fix **10.06.2026** for evidence of CSW No. 1.

Fix **12.06.2026** for evidence of CSW No. 2.

Fix **16.06.2026** for evidence of CSW No. 3.

Prosecution is to ensure the witnesses on the date fixed.

The bail petition is moved on behalf of the accused person Dhola @ Basir. Copy served.

Bail petition is moved.

Heard both sides.

Perused the case record.

Ld. Advocate for the accused person submitted that the accused person is in custody since 18.02.2026. Ld. Advocate submitted that the allegations brought against the accused person is fabricated. The accused person is not involved in the offence. Moreover the necessity of the accused in the interest of investigation is over. He further submitted that accused had surrendered on earlier occasion. Since then he is in custody. The charge against this accused was framed on 09.03.2026. Ld. Advocate submitted that the co accused persons are on bail. Detention of this accused Dhola @ Basir is not required at this stage. Ld. Advocate prayed for bail for the accused on any condition.

Ld. PP raised objection and submitted that this accused had been an absconder and due to his conduct, WA and Later WPA had to be issued. The case against this accused had to be filed for the present vide order no. 33 dated 24.06.2024. Thereafter charge was framed against rest two accused persons vide order No. 1 dated 18.09.2025. After commencement of trial this accused surrendered on 18.02.2026 and again charge had to be framed against him on 09.03.2026. Ld. P.P further submitted that the conduct of this accused is poor and if this accused is again granted bail, there is possibility that the accused will again abscond.

I have considered the prevailing circumstances.

Keeping in mind the exceptionally poor conduct of the accused and keeping in mind that he has misused the liberty of bail granted on him on an earlier occasion and also considering that the trial has suffered due to such poor conduction of the accused, I am not inclined to allow his prayer for bail. Accordingly, the bail prayer of the accused person Dhola @ Basir stands rejected at this stage.

The accused Dhola @ Basir is remanded to JC till to date.

The accused persons who are on bail are directed to appear before this Court on the date fixed.
