IO is present with CD along with a prayer for 14 days PC of the accused Abdul Malek @ Md. Malek is brought under arrest today.

Seen the accused challan, memos of arrest, medical slip, forwarding report.

Accused person is taken into custody.

I.O has also produced one yellow colour envelope contained in transparent plastic pouch containing ass colour mud like substance seems to be brown sugar weighing 103 grams marked as Exhibit-A, one yellow colour envelope contained in transparent plastic pouch containing ass colour mud like substance seems to be brown sugar weighing 200 grams marked as Exhibit-B, one yellow colour envelope contained in two black colour plastic carry bag marked as Exhibit-C and one red colour motorcycle styled as Apache RTR 160 having registration No. WGB 92G/6583 marked as Exhibit-E as per the seizure list.

Ld. Advocate appears on behalf of the accused by filing vakalatnama.

One bail petition is filed on behalf of the accused. Copy served.

Heard both sides.

Perused the case record and CD.

It appears that the case involves recovery of 303 gram brown sugar and accused person is brought on arrest today before this court.

In the circumstances considering materials in CD and such recovery, bail prayer of the accused persons is considered and rejected.

The Ld. PP-in-charge has prayed for police custody of the accused person as per the prayer of the I.O.

Perused the case record and CD.

Heard the accused person and also the Ld. Advocate for the accused as well as the I.O.

It appears that IO is present with a prayer for 14(fourteen) days PC which has been recommended by DY SP (D & T), Islampur PD, Uttar Dinapur.

He has prayed for permitting him to take the accused person in police custody for **14 days** for the purpose of the effective investigation.

I have examined the CD. It appears to me that granting the prayer for police custody to trace out and bursting out the involved miscreants and to recover more contraband articles is necessary and also for the interest of investigation.

In view of above, the prayer for police custody of accused persons is hereby allowed for **07 days**.

IO is permitted to take the accused persons **in police custody for 07 days i.e. for 27.06.2025 to 03.07.2025**. IO is directed to strictly follow the guidelines as given by the Hon'ble Apex Court while the accused person will be in police custody. He is further directed to get the accused person examined medically on every interval of 24 hrs and to produce them before this Court on **03.07.2025 at 1:00 p.m.**

To date (**03.07.2025**) for production of PC accused.

Let a copy of the order be supplied to the IO in open Court for strict compliance.
