**Regular P.O has been transferred.**

Today is fixed for production of the accused person namely Abdul Malek from J/C and Jaharul Alam @ Zaharul Alam from P/C and I.O's report along with CD.

Accused Abdul Malek is produced from J/C through VC and remanded to J.C.

Accused Jaharul Alam is produced from P/C and remanded to J/C.

I.O has prayed for further 07 (seven) days PC of the accused person namely Jaharul Alam @ Zaharul Alam.

Ld. Advocate on behalf of the accused persons is present.

I.O has also produced i) one zip-lock transparent plastic pouch containing ash colour wet mud like substances supposed to be 'Brown Sugar' measuring 183.05 gram marked as Exhibit 'A', (ii) one zip lock transparent plastic pouch containing ash colour wet mud like substance supposed to be brown sugar measuring 156.68 gram marked as Exhibit 'B', (iii) One small size silver colour digital weighing machine filled with pencil battery marked as Exhibit 'C', (iv) One black colour plastic carry bag marked as Exhibit 'D' and (v) One metal colour pendrive of sandisk company having stored capacity 16 GB containing screenshot of whasapp chatting, gallery, photo and so on which was taken from the mobile of PC accused.

Alamats are seen and returned.

Ld. PP-in-charge is present.

Bail petition is filed and moved on behalf of the accused persons namely Abdul Malek and Jaharul Alam @ Zaharul Alam.

Perused the case record and CD.

On perusal of the case record and the CD it appears that the case involves recovery of 183.05 gram and 156.68 gram supposed to be brown sugar.

The IO has prayed for further 7 (seven) days PC of accused 1) Jaharul Alam which has been recommended by DY SP (D & T) (, Islampur Police District).

He has prayed for permitting him to take the accused person namely, 1) Jaharul Alam in police custody for **7 days** for the purpose of the effective investigation to secure the arrest of other involved accused persons of Kaliachak, Malda, Gowhati, Assam and Manipur by identifying them and their houses respectively and to recover more drugs ie brown sugar, to find out racket of its illegal business and the chain of financing and to unearth the truth.

I have perused the CD. It appears to me that granting the prayer for police custody is necessary and also for the interest of further investigation.

In view of above, the prayer for police custody of accused person namely 1) Jaharul Alam @ Zaharul Alam is hereby allowed for **05 days**.

Considering the all materials on record as well as CD, the documents produced, recovered articles and considering the all aspects, bail prayer of the accused Jaharul Alam @ Zaharul Alam and another accused Abdul Malek stands rejected.

IO is permitted to take the accused person namely 1) Jaharul Alam @ Zaharul Alam **in police custody for 05 days i.e. for 13.11.2025 to 17.11.2025**.

IO is directed to strictly follow the guidelines as given by the Hon'ble Apex Court in the police custody of the accused person. I.O is further directed to get the accused person examined medically on every interval of 24 hrs and not to inflict any torture mentally or physically upon the accused person during the Police remand and to produce him before this Court on **18.11.2025 at 10:30 a.m.**

Accused **Abdul Malek** is remanded to JC till **27/11/2025**.

To date (**18.11.2025**) for production of PC accused person namely, **Jaharul Alam @ Zaharul Alam**.

**Let a copy of the order be supplied to the IO in open Court for strict compliance.**

**Return CD and call for CD again on the date fixed.**
