Today is fixed for production, appearance, supply of copy and further order.

I.O is present with a prayer to deposit the seized total 609 ATM cards of SBI to their Malkhana with a further prayer to allow further investigation regarding the same.

I.O has also produced those 609 ATM cards of SBI with specification in compliance with order dated 19.11.2024.

Seen, sealed and returned to keep the same in their Malkhana as safe custody.

Now the record is taken up to consider prayer of the I.O regarding safe custody of seized cash of Rs. 1,00,000/- (INR).

Heard Ld. Spl. P.P.

Heard I.O. in person.

Perused the case record and the prayer.

On perusal of the case record and prayer of the I.O and also after hearing the I.O in person it appears that Rs. 1,00,000/- (INR) were recovered from the possession of the accused Rajibul Islam and the same has been seized under seizure list dated 07.11.2024 in connection with the case during PC remand of the accused. From the petition it appears that I.O. has prayed for necessary order to deposit the said seized Indian currency notes in safe custody.

After hearing the I.O. and on perusal of his prayer it appears that the said prayer is made as per provisions of Section 451 Cr.P.C

In view of the aforesaid circumstances, prayer of the I.O. is considered and allowed.

Accordingly, I.O. is directed to deposit the said Indian currency notes to the Govt. Treasury under the district Uttar Dinajpur in view of Section 451 Cr.P.C.

It is further made clear that the aforesaid currency notes shall be deposited in the said Govt. Treasury till conclusion of the trial or any further order therewith and thereon.

I.O. is further directed to submit a report after depositing the said Indian currency notes with the Govt. Treasury under the district Uttar Dinajpur in compliance with the order by the date fixed.

In the circumstances after perusal of the prayer along with specification of the seized ATM cards submitted today in compliance with order dated 19.11.2024.

Seen the case record and also the specification of 14 pages and also perused the case record.

Considering the case involving Section 409 of IPC regarding defalcation of Government money prayer of the I.O is considered and allowed for the ends of justice and for further investigation with regard to the same.

Accordingly, I.O is directed to submit report on the aforesaid by the date fixed positively.

Fix 10.12.2024 for production, appearance reports and further order.

Let a copy of this order be handed over the I.O to Act accordingly.
