ORDER:

1. This order of mine shall dispose of bail application under Section 439 of the Cr.P.C., filed by accused/applicant Sonu Hussain @ Chhotu in the aforesaid FIR.
2. It was the arguments of the learned Counsel for applicant that applicant has been falsely implicated in this case. Accused is in custody since long. Presentation of challan and conclusion of trial will take long

time. No useful purpose will be served by detention of accused for an indefinite period. He has prayed for acceptance of the bail application.

3. On the other hand, the learned APP for the State has opposed the bail application, alleging that present accused deserves no concession of bail as serious allegations have been made against him and he has prayed for dismissal of the bail application.

4. I have considered the submissions made by the learned Addl.P.P.for the State as well as the learned Counsel for the applicant and have gone through the record.

5. The perusal of learned trial court reveals that the instant case was registered on the basis of secret information that accused Mohd. Javed @ Chhota Don, Munish @ Kalu, Soyab, Sharook, Sonu Hussain @ Chhotu, Babar @ Dabar, Sohail @ Sahil have formed a gang for committing robberies and they commit dacoity of thread from the hosieries, factories etc. by putting the people under the fear of death and they used to sell the dacoity goods to Saleem Baggar and Mohd. Mubarak and the accused persons are sitting in a vacant plot at Seera Road duly armed with deadly weapons and are planning to commit dacoity and they are having a Bolero Mahindra Pick up vehicle bearing No.PB 2020 TR-6191-A. Finding the information reliable, the present case was registered. Thereafter, accused persons namely Mohd. Javed, Mohd. Soyab, Sonu Hussain @ Chhotu, Saleem Baggar and Mohd. Mubarak were arrested at the spot, who got recovered above said Mahindra pick up, two datars of iron, 3 iron rods, 511 jackets, 600 sweat shirts in this case.

6. Accused/applicant Sonu Hussain @ Chhotu is already in custody since 31.10.2020. Presentation of challan and conclusion of trial is likely to take a long time. No useful purpose would be served by keeping him in custody for an indefinite period. Hence, accused/applicant is ordered to be released on bail subject to his furnishing personal bond in the sum of Rs.50,000/- with one surety in the like amount to the satisfaction of learned Illaqa/Duty Magistrate, subject to the following conditions:

1. That accused/applicant shall attend Court on each and every date of hearing.
2. That he shall not commit an offence similar to the offence of which he is accused, or suspected, of the commission of which he is suspected;
3. That he shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer or tamper with the evidence.
4. That he shall not leave the country without prior permission of Court.

7. Bail application file be consigned to the Record Room and police record be returned forthwith.
