**Regular P.O has been transferred.**

Accused person Md. Alam Sekh brought under arrest today.

IO is present with CD along with a prayer for 07 days PC of the accused Md. Alam Sekh.

Seen the accused challan, memo of arrest, medical slip, forwarding report.

I.O has also produced (i) One brown colour envelope pasted with label stated to have been containing one red colour soap case in which a packet contains brown sugar (seems to be) weight approx 96.23 gram (excluding soap case), (ii) One brown colour envelope pasted with label stated to have been containing one green colour soap case in which a packet contains brown sugar (seems to be) weight approx 92.24 gram (excluding soap case), (iii) One brown colour envelope pasted with label stated to have been containing one yellow-white colour soap case in which a packet contains brown sugar (seems to be) weight approx 163.09 gram (excluding soap case) and (iv) One transparent plastic packet contained in VIVO mobile phone as per seizure list.

No other articles has been produced.

Ld. Advocate appears on behalf of the accused by filing vakalatnama.

Two separate bail petitions are filed on behalf of the accused Md. Alam Sekh. Copy served.

Heard both sides.

Perused the case record and CD.

It appears that the case involves recovery of 351.56 gram brown sugar.

In the circumstances considering materials in CD and such recovery of of 351.56 gram brown sugar, bail prayer of the accused person stands rejected.

The Ld. PP-in-charge has prayed for police custody of the accused person as per the prayer of the I.O.

Perused the case record and CD.

Heard the accused person and also the Ld. Advocate for the accused as well as the I.O.

It appears that IO is present with a prayer for 07(seven) days PC which has been recommended by DY SP, HQ, Islampur PD, Uttar Dinapur. and it is duly signed by IC of Islampur PS with official seal.

He has prayed for permitting him to take the accused person in police custody for **07 days** for the purpose of thoroughly interrogation, to recover more narcotic contraband substance, to unearth the truth, to identify and arrest other involved accused persons in this case and to detect

the racket of the Narcotic business as well as chain of supply.

Perused the CD and prayer of I.O for police custody .

Heard I.O in person.

Heard PP-in-charge.

In view of above, the prayer for police custody of accused person is hereby allowed for **05 days**.

IO is permitted to take the accused person **Md. Alam Sekh in police custody for 05 days i.e. on and from 25.09.2025 to 29.09.2025**. IO is directed to strictly follow the guidelines as given by the Hon'ble Apex Court while the accused person will be in police custody. He is further directed to get the accused person examined medically on every interval of 24 hrs and to produce him before the Court of Ld. CJM, Raiganj, Uttar Dinajpur on **29.09.2025 at 1:00 p.m. (Due to puja vacation from 27.09.2025 to 23.10.2025)**.

To date (**29.09.2025**) for production of accused person from police remand.

**Let a copy of the order be supplied to the IO in open Court for strict compliance.**
