Today is fixed for evidence of CSW-6, 7 & 12.

02 accused persons namely Bhagirath Mohaldar and Ananda Singha are absent but represented by a petition u/s 317 of Cr.P.C. Later, both the accused are present and file late hazira.

Ld. PP-in-Charge is present with 03 witnesses namely Chaina Paul (CSW-12), Jharna Mohaldar (Barman) (CSW-6) and Jibon Mohaldar (CSW-7).

Ld. Advocate for the accused is also present.

The witness Chaina Paul (CSW-12) is examined in chief as PW-4.

The witnesses Jharna Mohaldar (Barman) (CSW-6) and Jibon Mohaldar (CSW-7) are examined in chief as PW-5 & 6.

The signature of PW-5 on seizure list 22.06.2019 is marked as **Exhibit-2**. The polythene packet containing seized cloth partially burnt and soaked with kerosene is marked as **MAT Exhibit-I**. The carbon copy of the label is marked as **Exhibit-3 (Objection)**. The signature of PW-5 on the carbon copy of the said label (Exhibit-3) which is marked as **Exhibit-3/1**. The polythene packet containing seized cloth soaked with kerosene is marked as **MAT Exhibit-II**. The label affixed on the cloth is marked as **Exhibit-4** and the signature of the witness on it is marked as **Exhibit-4/1**. The carbon copy of the label is marked as **Exhibit-4/2 (Objection)**. Signature of PW-5 on the carbon copy of the said label (Exhibit-4/2) is marked as **Exhibit-4/3**. The polythene packet containing seized article of some cloth burn ash which is marked as **MAT Exhibit-III**. The label kept in the polythene packet is marked as **Exhibit-5** and the signature of the witness on it is marked as **Exhibit-5/1**. The carbon copy of the label is marked as **Exhibit-5/2 (Objection)**. Signature of PW-5 on the carbon copy of the said label (Exhibit-5/2) is marked as **Exhibit-5/3**.

Considering the order No. 02 dated 27.02.2023, the cross-examination of PW-4, PW-5 and PW-6 are deferred u/s 231 (2) of the Cr.P.C. Hence, the cross-examination of PW-1 to PW-6 will be done on a single day.

PW-4, PW-5 & PW-6 are released at this moment.

Fix **18.07.2024** for **cross-examination of PW-1 to PW-6 by the accused as per section 231 (2) of the Cr.P.C.**

Accused as before.
