

Jatinder Kaur Vs.State of Punjab.

1. Trial court file received. Heard on bail application filed by applicant/accused Jatinder Kaur wife of Harjinder Singh Jaura in FIR No.28 dated 14.03.2011 u/s 120-B /420 /465 /467 /468 /471 IPC, PS Division No.2, Jalandhar.

2. Sh. Kanwar Opinder Singh, Adv has argued that accused is innocent. FIR was not even registered against the accused. She has been summoned as additional accused by the court . She is ready to appear and face the trial. She should be granted bail.

3. On the other hand, ld. APP for the State has opposed the bail application and has argued for dismissal of the same.

4. I have considered the respective submissions and have gone through the file.

5. Rajiv Verma, Manager, Andhra Bank, Basti Adda, Jalandhar moved complaint to the police to the effect that car loan of Rs.8,00,000/- was sanctioned on 16.10.2008 in the name of Harjinder Singh Jaura who was to purchase the car from RNS Motors, Ludhiana. Collateral Security was given by Harjinder Singh Jaura & Jatinder Kaur. Bank issued draft of Rs.8,00,000/- in

the name of RNS Motors. Accused produced receipts of the said company but did not supply copy of RC, Insurance, sales Certificate, bill etc. On inquiry, they came to know that draft has been credited to CD account of RNS Motors maintained by Amandeep Singh Jaura s/o Harjinder Singh Jaura. Car was never purchased for which the loan was taken. Bogus receipts were produced. They have cheated the bank. On the basis of this complaint, inquiry was conducted and FIR was registered against Harjinder Singh Jaura, Amardeep Singh Jaura, Rajender Pal Singh, Branch Manager and Shiv Kumar Prashar, Assistant Manager. After investigation, police presented challan against Harjinder Singh Jaura and Shiv Kumar Prashar. During trial, on the basis of evidence lead before the Trial court , applicant Jatinder Kaur and Amandeep Singh have been summoned as additional accused vide order dated 13.10.2018 by the Ld. Trial court for offences under section 120-B,420,465,467,468 and 471 IPC.

6. Applicant/accused Jatinder Kaur was though named in the complaint by complainant Rajiv Verma Manager but FIR was not registered against her. After investigation, police presented the challan against Harjinder Singh Jaura and Shiv Kumar. Applicant has been summoned as additional accused , on the basis of evidence led in the Trial court. She is ready to face the trial. Her criminal liability, if any, will be determined during the trial. Considering these facts, she is granted interim bail with a direction to appear

before the Id. Trial/Duty Magistrate within ten days, who will admit her to bail as per his/her satisfaction. Accused will produce his affidavit of compliance of this order in this court on 17.07.2019, so as to further proceed with this bail application. Trial court file be returned. File be put up on 17.07.2019.
