

CHARGES WITH SEVEN HEADS

[No. XXVII (II), SCHEDULE V, ACT V, 1808]

Sections 221, 222, 223, Code of Criminal Procedure.

hereby charge you ⁽²⁾

as follows:-

Ayubuddin Mondal @ Ayub Mondal and Tuhin
Mondal**

Firstly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, Police personnel of Hili Police apprehended Morsed Mondal and found that tried to smuggle of 1100 nos. of Buprenorphine Injection IP amounting to commercial quantity with the help of Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal without any valid documents for the purpose of sell or transport and you all have thereby committed an offence punishable **U/S.21(c) of the NDPS Act**, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.

Secondly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, Police personnel of Hili Police apprehended Morsed Mondal and found that tried to smuggle of 1100 nos. of Buprenorphine Injection IP amounting to commercial quantity with the help of Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal without any valid documents for the purpose of sell or transport and you all have thereby committed an offence punishable **U/S.22(c) of the NDPS Act**, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.

Thirdly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, Police personnel of Hili Police apprehended Morsed Mondal and found that tried to smuggle of 1100 nos. of Buprenorphine Injection IP amounting to commercial quantity with the help of Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal without any valid documents for the purpose of transship, export or import and you all have thereby committed an offence punishable **U/S.23(C) of the NDPS Act**, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.

Fourthly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, Police personnel of Hili Police apprehended Morsed Mondal and found that used Hero Splendor Plus Motorcycle having Reg. No.WBQ-4550 with a view to smuggle of 1100 nos. of Buprenorphine Injection IP amounting to commercial quantity with the help of Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal without any valid documents and you all have thereby committed an offence punishable **U/S.25 of the NDPS Act**, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.

Fifthly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, Police personnel of Hili Police apprehended Morsed Mondal and found that tried to smuggle of 1100 nos. of Buprenorphine Injection IP amounting to commercial quantity with the help of Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal without any valid documents for the purpose of transship, export or import and you all financed the said illicit traffic and you both have thereby committed an offence punishable **U/S.27(A) of the NDPS Act**, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.

Sixthly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, Police personnel of Hili Police apprehended Morsed Mondal and found that tried to smuggle of 1100 nos. of Buprenorphine Injection IP amounting to commercial quantity with the help of Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal thus you both attempted to comit an offence punishable under the NDPS Act. Or to cause such offence to be committed and in such attempted did any an act, and you both have thereby committed an offence punishable **U/S.28 of the NDPS Act**, and within my cognizance.

And I hereby direct that you be tried by this Court on the said charge.

Seventhly---- That on 12.10.2025 in between 09.45 hrs to 11.40 hrs at Mera Aptair, Amtali Bridge, under PS Hili, Dist. Dakshin Dinajpur, you both being a party to a criminal conspiracy to comkmit an offence punishable under the provision of NDPS Act and you both have thereby committed an offence punishable **u/s. 29 of the NDPS Act** and within my cognizance of this Court.

The contents of the charges are read over and explained to the accused persons in Bengali to which they pleads **not guilty** and claims to be tried.

Accused persons namely **Tuhin Mondal** on Court bail is present by filing hazira.

Today is fixed for consideration of charge.

The learned P.P-in-charge and the learned advocate for the accused person are present.

A bail petition is filed on behalf of the said accused **Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal**. Copy served. The said petition is taken up for hearing.

Ld. Adv for the accused person prays for bail on the ground of non-absconsion as the accused being local resident. The prayer is opposed by the Ld. P.P as the investigation of the case is complete and charge sheet has been submitted.

Heard both sides and considering the materials on record including the quantity of seizure of contrabands, the prayer for bail of accused **Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal** is hereby **rejected**.

Record is taken up for framing of charge.

Heard both sides. Perused the materials on record and the case diary. Considered.

Considering C.D. and material on record, it appears that a prima facie charge under Sections 21(c)/22(c)/23(c)/25/27A/28/29 of NDPS Act is made out against accused persons namely **Murshed Ali Mondal, Ayubuddin Mondal @ Ayubuddin Mondal @ Ayub Mondal and Tuhin Mondal**.

The contents of charge, is read over and explained to the accused person to which he pleaded **not guilty** and claimed to be tried.

Formal charge is written in separate sheet and kept in the record.

Heard both sides in order to ascertain if they wish to carry out admission of any document under Section 294 of the Cr.P.C. The accused refused to carry out any such admission.
