Commitment order:

1. Challan against the above named accused has been forwarded by Officer in charge of Police Station, P.S. Mattewal, District Amritsar, to face trial for the offence punishable under Section 306, 34 of IPC.

2. The FIR in question was registered on the statement of Sukhwinder Singh son of Kartar Singh (hereinafter referred to as complainant) which he suffered on 26.04.2024, before the police party headed by ASI Kuldeep Singh. The complainant stated that 10 years ago, the marriage of his younger daughter Mandeep Kaur was solemnized with

Jatinder Singh and from their wedlock two male children were born. After two years of marriage, Jatinder Singh used to beat Mandeep Kaur under intoxicant state and his mother also supported him (accused) in it. It is further submitted that several times, Jatinder Singh had thrown Mandeep Kaur out of the house after beating her. But like every time, respectable persons of village effected the compromise between the parties and sent Mandeep Kaur to her matrimonial home. And again, just 5 days ago, Jatinder Singh had thrown Mandeep Kaur out of the house. It is further stated by the complainant that at about 1:00 p.m., he came know that his daughter Mandeep Kaur had consumed some poisonous substance due to which she lost her life during treatment. It is further stated that because of domestic abuse, his (complainant) daughter Mandeep Kaur committed suicide. On his this statement the FIR under Section 306, 34 of IPC was registered. Investigation helmed. After completion of investigation, challan was presented against the accused Jatinder Singh and the copies of challan were supplied to the counsel for accused free of cost.

3. From the facts as detailed in the FIR, prima facie case for offence punishable under Sections 306, 34 of IPC is made out. The offence under Section 306 IPC is exclusively triable by the Ld. Court of Sessions. Hence, the present case is hereby committed to Ld. Court of Sessions at Amritsar, for 04.10.2024. Amritsar Jail authorities are directed to produce the accused Jatinder Singh before the Court of learned Sessions Judge Amritsar, on the date fixed at 10.00 a.m. The commitment of this case to Ld. Court of Sessions, Amritsar be notified to the Public Prosecutor.

Ahlmad is directed to send the record of the present case along with the documents, complete in all respects to the Court of learned Sessions Judge, Amritsar, well before the date fixed.
