ORDER:

1. The instant bail application has been filed under Section 439 Cr.P.C., praying for grant of regular bail to the accused/applicant in case FIR No. 165, dated 22.10.2019, under Section 406, 420 IPC and Section 13 of Punjab Travel Professional (Regulation) Act, Police Station Sadar Nakodar,

2. The bail application of the accused is considered. The allegation against the accused/applicant is that he took ₹2,60,000/- (Rupees two lakhs sixty thousand) for sending the complainant to Cyprus, but instead of sending him to Cyprus he sent him to Malaysia and has also not provided the job as promised by the accused/applicant.

3. Ld. counsel for the accused/applicant argued that accused has been in custody since 17.02.2020. Even the matter has been settled between the parties and they are going to move quashing petition before the Hon'ble High Court. In support of his contention he placed on file an affidavit of the complainant, who is also present in the court. As per affidavit, placed on file, the matter has already been settled between the parties.

4. In view of nature of the offence, which are triable by the court of Sessions, period of confinement that accused has been in custody since 17.02.2020 and the fact that the parties have arrived at a compromise, a case for granting bail to the accused/applicant is made out. Accordingly, bail application is allowed and accused/applicant is directed to be released on bail, subject to furnishing of bail bonds to the tune of ₹70,000/- with

one surety in the like amount, to the satisfaction of Learned Illaqa Magistrate/Duty Magistrate. Bail application file be consigned to record room.
