JUDGMENT

The above named accused had been sent up by the S.H.O. Police Station, PP Baltana PS Zirakpur to face trial for offence punishable under Section 188 of the Indian Penal Code, 1860 (hereinafter referred to as

IPC).

2. The brief facts of the case are that on 09.12.2020 at about 10:15 PM in the area of Kalgidhar Enclave, Baltana, you accused was found violating the orders of District Magistrate, SAS Nagar qua the lockdown/curfew qua Covid-19 and thereby endangering human life and health. On the basis of same, the instant FIR was registered against the accused. Investigation in the matter was started and after completion of necessary investigation, the challan was presented.

3. Copies of challan have been supplied to accused free of costs, as required U/s. 207 Cr.P.C.

4. Finding a *prima-facie* case against the accused, the accused has been charge-sheeted u/s 188 IPC to which he pleaded guilty and did not claim any trial. The confession of the accused is voluntary without any coercion or undue influence. The accused wished to confess despite being told that he was not bound to do so and if he does so, it may be used against him. In view of the confession of the accused, he is held guilty and convicted for the offence under Section 188 of the IPC. Let he be heard on question of sentence.
