ORDER

1. This application for regular bail has been filed by

applicant/accused Gurbhej Singh @ Harbhej Singh @ Bheja son of Sawinder Singh in case FIR No.260 dated 9.10.2015 for the offence under sections 379-B/(2)/323/336/201 IPC and 25/27/54/59 Arms Act registered at Police Station Sultanwind, Amritsar.

2. On notice, Public Prosecutor opposed the bail application.

3. I have heard counsel for the applicant/accused and the Public

prosecutor for the State and have gone through the record of the Trial Court as well as the police record.

4. As per allegations on record, on 9.10.2015 complainant Beant Singh was going to attend his duty as a Security Guard in Hero Agency near Petrol Pump in the area of Jalandhar Amritsar G.T. road. At about 5.30PM when the complainant reached near Guru Nanak Dairy, three youngmen on motorcycle came from ahead. Two pillion riders got down from motorcycle and snatched the bag of complainant at pistol point. One of them also fired two shots in the air and then they sped away from there. The bag was containing Rs.550/-, his uniform and some documents. Thereafter the applicant was arrested in this case on 10.11.2015. There are also allegations that the applicant and other two accused namely Amandeep Singh and Vinod Kumar got recovered

empty bag belonging to the complainant from the disclosed place on the basis of disclosure statement.

5. The challan was presented in this case on 17.11.2018 against the applicant and other two accused. Even from the perusal of said challan, it appears that applicant was in custody in the present case at the time of presentation of challan. Thus even from the presentation of challan, now applicant is in custody for the last more than four months. It will take time for conclusion of trial as the case has not been committed to the Court of Sessions till date.

6. So no purpose will be served by detaining the applicant in custody for any further period. Thus without commenting upon the merits of the case, this bail application is allowed and applicant is directed to be released on bail on his furnishing personal bond in the sum of Rs.50,000/-

with one surety in the like amount, to the satisfaction of Illaqa/Duty Magistrate, subject to following terms and conditions:-

- 1) that applicant/accused shall not give any threat or inducement to any prosecution witnesses;
- 2) that applicant/accused shall not leave India without prior permission of the court.

Record of the trial court be returned alongwith copy of this order. Police record be also returned. File be consigned to record room.
