The custody of Gulam Mustafa, Arman Raza and Bikas Chowdhury are not send from Balurghat Central Correctional Home and Malda District Correctional Home.

The rest custody accused are received.

The accused Ashim Babu on CB is present while accused Saddam Alam on CB is absent by petition under Section 355 of BNSS.

The Ld. PP files hazira of witness C-497 Ganesh Kar and C-461 Aroshan Rai who are present and examined as CSW 9 and 10. They identified their signatures over the seizure lists which are marked as Exhibit 6 and 6/1 and another is Exhibit-7. They also identified the Mat Exhibit-V to VII, cross-examined and discharged.

The Ld. Advocates on behalf of Golam Mustafa files a petition stating that the accused not getting proper treatment at Balurghat Central Correctional Home and though he was referred to Malda Correctional Home for better treatment. He was intentionally not send up there. The Advocate on behalf of the accused prayed for necessary direction upon the Superintendent of Balurghat Central Correctional Home.

Considering the petition, the Superintendent of Balurghat Central Correctional Home is hereby directed to take necessary initiative for his treatment and health accordingly. He is at liberty to send the undertrial for his medical benefit to appropriate place accordingly.

Fix **25.07.2025, 28.07.2025, 29.07.2025** for the other CS witnesses and the prosecution is directed to issue summons accordingly.
