The accused Md. Tamrej, Md. Ali and Debendra Paswan are present physically from the Correctional Homes at Islampur.

Two custodial accused namely Bikash Kumar Chowdhury and Md. Arman Raja produced through virtual mode from Malda District Correctional Home.

Remaining one custodial accused namely Gulam Mustafa is produced through virtual mode from Balurghat Central Correctional Home.

The accused Ashim Babu on CB is present while accused Saddam Alam on CB is absent by petition under Section 355 of BNSS. His absent petition is accepted and allowed.
