Today is fixed for evidence.

All the eight accused on custody are produced from several Correctional Homes.

Ld. P.P Mukhtar Ahmed and the Ld. defence Advocates in four sets namely, Sanjay Kumar, Gurudas Saha, Firoj Ahmed and Prasunjoy Sinha are present.

Bail petitions on behalf of Md. Tamrej and Ashimbabu @ Washim are submitted.

It appears that the Hon'ble High Court on several occasions rejected their bail applications. Today after charge the trial of this case is ready to proceed already the defacto complainant Md. Mashruque Inam Rahi is present for adducing evidence.

Ld. PP raised vehement objection stating that it is a case of professional killers and if one of them released in bail he will positively abscond. It is the chickenneck of the State and if someone fled from the territory of Bengal it is difficult to catch him back.

Considering the gravity of this case and as all the accused are in custody, the bail prayers of Md. Tamrej and Ashimbabu @ Washim are rejected.

The supplementary charge sheet is received from the ACJM, Islampur. Let the same be kept with the record. The prosecution is directed to supply the copy of the same to the defence side at once.

The evidence of the defacto complainant Md. Mashruque Inam Rahi is recorded. The witness during his chief exhibited the FIR as Ext.1. He is cross-examined and discharged.

To date (21.12.2024) for further evidence.

Accused be produced accordingly.

The Superintendent, Islampur Sub-Correctional Home is hereby directed to keep all the eight accused persons of this case to his Correction Home till the trial of this is over.

The Superintendents of Balurghat Central Correctional Home, Raiganj Correctional Home are directed to shifted the accused namely, **Gulam Mustafa and Saddam Alam** at Islampur Sub-Correctional Home accordingly.

Let a copy of this order be forwarded to the Superintendents of Balurghat Central Correctional Home, Raiganj Correctional Home and Islampur Sub-Correctional Home at once.
