ORDER:

Heard on the application filed by the applicant/accused for
releasing him on bail under Section 438 Cr.P.C. in case FIR No.105 dated:
28.06.2018, Under Section 61/1/14 Excise Act registered at P.S.City-1
Lehra. The applicant-accused is apprehending his arrest for the offence
mentioned above. It is alleged that the applicant has been falsely
implicated in the present case.

2. Notice of the application was issued to the State. Record was
also requisitioned. ASI Jagjit Singh no.509/Sangrur has suffered a
statement that the applicant-accused has already joined the investigation
in pursuance of order of interim bail passed by this court on 07.07.2018

and he is no more required by the police for custodial interrogation. So, in view of these facts, the interim bail order dated 07.07.2018 is made absolute and this application for anticipatory bail is allowed with the undertaking that the applicant-accused :-

- (a). shall attend the proceedings with the Investigating Officer/ Court in accordance with the conditions of the bond executed by him,
- (b) shall not commit any offence similar to the above alleged offences,
- (c) shall not directly or indirectly make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer or tamper with the evidence.
- (d) shall not leave India without prior permission of the court.
