The prayer of applicant for taking the V.G. in her custody is considered and allowed.

Let the custody of the victim girl be given to the applicant on furnishing a P.R. bond of Rs.1,000/- with an undertaking that she will keep the victim girl under proper care and proper protection, shall cooperate with the I.O. for further investigation and shall produce the victim girl before the court as and when called for.

I.O files a petition praying for supplying copy of 183 BNSS.

Prayer of the I.O stands allowed.

Let a copy of the statement of the victim girl recorded u/s 183 BNSS be supplied to the I.O at once.
