Submission of Learned counsel for the petitioner :

Learned counsel for the petitioner submitted that petitioner has

Contd..... 19.11.2022	been falsely implicated and he did not take part in the alleged occurrence. He further submitted that from the statement of the witnesses, it appears that he was there. However, he did not made any assault and the involvement of this petitioner in the alleged death of Sushila Oraon has not been stated by the witnesses of the prosecution. Therefore, petitioner may kindly be enlarged on bail. <u>Submission of Learned Public Prosecutor :</u> Learned P.P opposes the prayer for bail and submitted that witnesses have stated about the presence of this petitioner at the place of occurrence and he was instigating other to commit the offence. Therefore, petitioner does not deserve to be enlarged on bail. <u>Brief facts of the case:</u> One Santosh Oraon is the informant. The alleged occurrence had taken place on 08.08.2021 at 09:30 P.M. Eight persons including this petitioner came to the house of the informant and asked all the family members to came out from their home. There was a allegation of practicing witch by one Sushila Oraon. As far as this petitioner is concerned, he was outside the house and was calling Sushila Oraon as “Daain”. Witnesses have stated that he was the headman of the family of the accused persons and if the petitioner wanted the incident would not have happened.
