On notice, Ld. Addl.P.P. appeared for respondent-State.

Police record presented by her is perused and returned. Heard on this application of applicant/accused for anticipatory bail in this case.

2. Ld. Counsel for applicant contended that latter has been falsely implicated in this case. He has no concern with co-accused or with the alleged offence. He is not named in the FIR. Nothing is to be recovered from him. He is ready to join the investigation. Therefore, the prayer to admit him to anticipatory bail.

3. Ld. Addl.P.P. opposed the bail application and prayed for its dismissal in view of nature and gravity of offence.

4. Complainant Sandeep Singh alleged before police that he is resident of Mansa and is President of Cow Protection Unit of Mansa District. It was about 12.40 AM on 26.12.2020. He alongwith Karamjit Singh was present at Bus Stand Kot Lallu. He received secret information that non-applicants Vijaypal, Raj Singh and Arjan Singh (whom complainant already knew), alongwith two unidentified persons, were present in Grain Market of Village Dalel Singh Wala. They were with

Canter No.UK-07CB-2918 in which they had 10-12 Cows and Oxen. Complainant knew that these persons for the last quite some time have been smuggling Cows from out of Punjab to other States for their slaughtering which hurts religious feelings of complainant party. On the basis of this intimation the current FIR was registered. Disclosed place was raided by the police. The accused had fled from there. Above said Canter was recovered and from near it 11 Oxen were recovered. The same and Canter were taken in police possession. During investigation stage, complainant suffered statement under Section 161 Cr.P.C. on 19.01.2021 disclosing that the two unnamed accused were Canter driver Haroon (current applicant), and Sanjay alias Fada. None of the accused so far has been arrested. As per Investigating Agency, the current applicant is driver of the above said vehicle. This vehicle was used in transporting of above said cattle illegally. Identification of applicant and his custodial interrogation would be required to bring out his involvement and the modus operandi in committing the crime. He therefore does not deserve to be admitted to anticipatory bail. This bail application is dismissed. Bail application file be consigned to the record room.
