Accused Golam Md. is produced from JC.

An intimation received from 'The Superintendent, Siliguri Special Correctional Home' regarding non production of accused Md. Najish Ahsan on the issue that large No. of police are deployed for VVIP duty of Honble Home Minister and others.

The rest seven accused persons on CB are present on dock.

The Ld. PP in charge and the Ld. Advocates on behalf of the accused persons are present.

Three witnesses namely Abdul Karim, Saidul and Khushnama Parveen are present before this Court and examined as **PW-3**, **PW-4** and **PW-5**. The 164 statements of the above witnesses are marked as Exbt- 6 and 6/1, 7 and 7/1 and 8 and 8/1. The witness Khushnama Parveen is a child witness. Before examination her aptitude test taken and after satisfaction she was examined in camera. All the witnesses are deferred for cross examination on the earlier prayer of 231 by the accused persons.

The Ld. P.P. and defence council jointly pray that the under trial Md. Najish Ahsan Sahani be shifted to 'Islampur Sub Correctional Home' which is very closed to this Court and on his arrival at 'Islampur Sub Correctional Home' the evidence will started earlier and no such huge police deployment is required to brought him to this Court on everyday for trial.

Let 'The Superintendent, Siliguri Special Correctional Home, Darjeeling' is hereby directed to take effective steps so that the accused **Md Najish Ahsan Sahani** be shifted to the local 'Islampur Sub Correctional Home' at earliest.

It is fully difficult to produce the accused from a distance of 70 Km and from other district each and every day. The direction is given for interest of justice.

Let a copy of this order with such direction be forwarded to 'The Superintendent, Siliguri Special Correctional Home, Darjeeling' and 'Islampur Sub Correction Home'.
