On perusal of case record it appears that a black coloured venue car was seized vide seizure list dated 20.02.2023 in connection with this case and that car was exhibited on 06.02.2025 (Mat Exbt – VII) and kept in the Goalpokher thana premises.

Ld. P.P. stated that as the vehicle is already marked as exhibited, it should not be given back during pendency of trial.

Any how the petition is taken up for hearing.

Mean while the OC, Goalpokher PS is directed to produce the said alamat (Mat Exbt-VII) on 20.05.2025 for marking the vehicle permanently and in laminated affixing the several part of the vehicle in presence of the BC of this Court.
