Today is fixed for production and cross-examination of witness.

Accused Golam and Naziz Ahsan are produced through VC from Islampur Sub-Correctional Home.

The rest seven accused persons on CB, are present on dock.

Ld. PP-in-charge is present along with two witnesses namely Subhan and Ali Hussain who are examined as PW-7 and PW-8 for cross-examination.

The Ld. Advocate Amitabha Ganguly is present on behalf of the accused Tousif Reza @ Raja Babu and Md. Najish Ahsan.

Ld. Advocate Md. Jalaluddin Khanna is present on behalf of accused Sahadat Reza and Sardar Ahhamed.

Ld. Advocate Firoz Ahammed for the accused Golam Md., Noor Alam, Sahid and Sah Alam is present in the Court room and;

The Ld. Advocate Soumendra Majumder is present on behalf of accused Saklin Mustak.

PW-7 and PW-10 namely Subhan and Ali Hussain are cross-examined in full by four sets and discharge.

No other witness are present today. Ld. PP in-charge submitted that the case is also fixed on tomorrow i.e. on 21.05.2025 for cross-examination of PW-5 and PW-11 namely Khusnama Parveen and Mariyam Nisha but due to her Class-VIII exam on tomorrow, the PW-5 is not available and as such he prayed for another date.

Ld. Advocate on behalf of the accused persons are prayed for cross-examination of PW-5 and PW-11 together and in such situation, they also prayed to defer the case to another date for cross-examining the above witnesses.

Accordingly, the case is re-scheduled.

Fix **19.06.2025** for cross-examination of PW-12 and PW-15,
and **20.06.2025** for cross-examination of PW-5 and PW-11.

The Advocate Mr. Khanna on behalf of accused Sehedat Reza and another files a petition for correction in the cross-examination of PW-1 in Page-4“at the time of firing, I was in the house of Abdul Karim” will be “at the time firing **he took shelter** in the house of Abdul Karim”. As the certified copies of the evidence are already issued, the parties are directed to deposit their respective certified copies for the necessary correction. The respective part will be corrected on the consent of all the sides and prosecution on the

next date after receiving the certified copies of the evidence.

The Ld. Advocate on behalf of Tousif Reza on the last occasion files a petition for returning the alamat **Mat Exhibit (VII)** the Car (**WB92-G/7625**) against Zimmanama as the same is damaged and deteriorating in the Goalpokher PS premises. He refers the weather condition of this region.

The Mat Exhibits No. **VII and VIIA** (cars) being no. WB92G/7625 and WB92E/2428 are produced today but there is no such cross-examination in respect of the above Mat Exhibits.

The Ld. PP-in-charge stated that he has no objection regarding return of alamat Mat Exhibit (VII) the Car (WB92-G/7625) to its owner with proper verification against Zimma with direction to produce the same when required and/or as per direction of the Ld. Court.

He further submitted that till the disposal of this case the alamat Mat Exhibit VII be not change its colour, shape and the ownership till the disposal of this case and the vehicle be use only within the jurisdiction of this Court.

Considering all above and on such condition the BC of this Court is directed to check the alamat, kept in the Court Parking and is directed to fix the labels in the several safe and protected places inside the vehicle.

The accused is liable to maintain all the labels personally and in violation of above, the alamat Mat Exhibit-VII will be taken back under the custody of this Court.

The O.C. of Goalpokher PS is hereby directed to return the vehicle on the above conditions as stated by the PP-in-charge of this case and on proper verification about the vehicle with its papers.

The petitioner/accused is further directed to give a zimmanama of Rs. 10,00,000/- (Ten Lakhs) against the vehicles before this Court meanwhile.

Let a copy of this order be forwarded to O.C. of Goalpokher PS for compliance.

Accused be and as before. Prosecution to take steps accordingly.
